**I. Call to Order:**

- a. The meeting was called to order by Chair, Mike Bishop at 1:33 PM. A quorum was established.

**II. Welcome and Introductions:**

- a. Chair Mike Bishop welcomed all in attendance and all members, and guests shared their name, title, and organization represented.

**VII. Reports:**

a. **Advisory Council Chair Report:**

- i. This report was made by Chair Mike Bishop.

ii. **Advisory Council Membership Status:**

- 1. Current Vacancies: 2 Fresno County, 6 Madera County, and 1 City of Fresno.
- 2. The Advisory Council has significant vacancies. Efforts to recruit from Madera have been challenging despite offering mileage reimbursement.
- 3. **Membership Criteria:** 50% of the Advisory Council members must be aged 60 and older. Joint Powers of Authority (JPA) representation needed from each service area (City of Fresno, City of Madera County, and Fresno County).

iii. **Brief Announcements of Upcoming Events**

- 1. Tonya Frost shared that her group, Together for Veterans, is interested in partnering with FMAAA to support their Veterans Benefit Briefings at senior living facilities and senior centers. These events bring Veteran Service Officers onsite to meet one-on-one with seniors about available benefits. The next briefing is planned for February 19 in either Selma or Reedley. Tonya requested FMAAA representation at these events to share information about our programs. Miles R. confirmed that he would be happy to attend on behalf of FMAAA.
- 2. Chair Mike Bishop reported on his and Anne Bishop's Legacy Planning Workshop series and how it is designed to prepare individuals for the next steps of their lives and ensure they have all their paperwork, finances, and other key information documented and accounted for.

3. Angela Stillwell shared that her staff member is finishing their doctoral program and is conducting a survey on hoarding among the elderly for their dissertation and needs 75 responses. The group agreed to share the survey link via email to help collect responses and bring awareness to the issue.

**b. Committee Updates and Reports:**

**i. Food and Resource Insecurity Report:**

1. Committee Chair, Angela Stillwell reported that the food insecurity guide has been updated to be printer-friendly. The updated version will be emailed to the group and has been distributed to FMAAA staff by Miles R. This resource was included in the paper copy of the Advisory Council's Agendas.

**ii. Housing Insecurity Committee Report:**

1. Anne Bishop reported that her committee did not have any updates at the time of the meeting but planned to meet again soon. Miles R. mentioned that he emailed the updated FMAAA Housing Resource Guide to the Council with the agenda

**c. Governing Board Meeting:**

i. Miles R. reported that the next Governing Board meeting was scheduled for Wednesday, December 10<sup>th</sup>, 2025, but was canceled. The next FMAAA Governing Board meeting will be on Wednesday, January 14, 2026, at the Fig Garden Library.

**d. California Senior Legislative Report:**

i. Miles R. reported that FMAAA is allotted one senator and two assembly member positions for CSL. Minerva Garcia currently serves as the senator, and both assembly seats are vacant. Interim members may be appointed until the 2026 election, which requires public notice and is open to all older adults in the service area to run and vote that are 60 years of age or older. Stefanie Diaz and Jan Clagg volunteered to fill the two interim vacancies, and Miles R. will follow up with them with additional information.

**e. Triple-A Council of California (TACC) Report:**

i. Tonya Frost had nothing to report at the time of the meeting.

**VIII. Fresno-Madera Area Agency on Aging Administrative Update:**

**a. Miles R. gave the following updates:**

- i. FMAAA is working to open Parlier and Del Rey as congregate nutrition sites.
- ii. FMAAA is hiring two new employees, a Home Delivered Meals Eligibility Worker and a Finance Manager.


